**Subject: Additional Notional Service under Regulation 26 of United Bank of India (Employees) Pension Regulation 1995 in connection with implementation of Judgement of Hon'ble Supreme Court & IBA clarification through Circular No.CIR/HR&IR/SKK/2017-18/4439 dated 01.02.2018**

As per the provisions of regulation, 26 of Bank Employees' Pension Regulations, 1995 an employee shall be eligible to add to his service qualifying for superannuation pension (but not for any other class of pension) the actual period not exceeding one fourth of the length of his service or the actual period by which his age at the time of recruitment exceeded the upper age limit specified by the Bank for direct recruitment or for a period of five years whichever is less, if the service or the post to which the employee is appointed is one:-

- For which post-graduate research, or specialist qualification or experience in scientific, technological or professional fields, is essential, and
- To which candidates of age exceeding the upper age limit specified for direct recruitment are normally recruited.
- For which the candidate was given age relaxation over and above the maximum age limit fixed by the Bank on account of his possessing higher qualifications or experience

Provided that this concession shall not be admissible to an employee unless his actual qualifying service at the time he quits the service of the Bank is not less than ten years.

Provided further that this concession shall be admissible if the recruitment rules in respect of the said service or post contain specific provision that the service or post is one which carries benefit of this regulation.

Provided also that the recruitment rules in respect of any service or post which carries the benefit of this regulation shall be made with the approval of the Central Government.

2. IBA vide circular no. CIR/HR&IR/SKK/2017-18/4439 dated 01.02.2018 has examined the matter in view of Supreme Court judgment dated 20<sup>th</sup> July, 2017 and advised all Public Sector Banks (except State Bank of India), to implement the judgment of Hon'ble Supreme Court as Regulation, 26 of Bank Employees Pension Regulation 1995, which is uniformly applicable to all Public Sector Banks. In view of the Supreme Court verdict and as per direction of IBA the benefit of additional notional service will have to be given to all those employees who fall within the ambit of clauses (a) and (b) of the Regulation 26 of the Pension Regulations, 1995.

3. In view of clarification given by IBA vide their circular dated 01.02.2018 it has been decided by our Bank to extend the above benefit to the pensioner who fall within the ambit of clause (a) & (b) of regulation 26 of the Pension Regulations, 1995.

**4. The retirees who are covered under above regulation are required to submit the information on the enclosed Application (Annexure A) and information format (Annexure B) through their respective pension paying branches.** The branch will forward the same with recommendation **immediately** to Staff Pension Department after verifying the contents in the application as well as the information format submitted by the pensioner on the basis of records available at their end.

5. After the receipt of duly filled in Application along with the information format from the branches the same will be checked/verified by the Staff Pension Department with the available record with them to ascertain the eligibility of the retirees under Section 26 of the Pension Regulation. Thereafter, the Staff Pension Department will allow the benefit of additional notional service to the eligible applicants and release revised pension and arrear thereof.

All concerned are advised to bring the contents of this circular to the knowledge of the eligible retirees.

A copy of the circular may be displayed in the notice board of the branches and offices for information of all concerned.
